



2021 Summer Financial Aid Information at WCC

Aloha. Pell Grants and Direct Stafford Loans are available to eligible students for the summer session at Windward Community College (WCC). Students must complete a **2020-2021 FAFSA**. Please note that the summer tuition rate for most classes is higher than the Fall/Spring semester rates. If you have any questions regarding your summer aid eligibility or the application, please call us at (808) 235-7449 or email us at wccfao@hawaii.edu.

Summer Eligibility Information

- WCC must be your home campus for 2021 summer session.
- Only courses offered by WCC and count for your WCC degree are considered for summer aid enrollment.
- You must be registered for the WCC summer course(s) at the time you submit this form.
- Direct Stafford Loan applicants must be enrolled for at least six (6) credits at WCC for the summer session and show loan eligibility.
- Students must meet Financial Aid Satisfactory Academic Progress Policy requirements prior to the release of summer session aid.
- The aid awarded may be prorated based on different start dates for summer session courses.
- Summer classes that **do not charge tuition** are **NOT** eligible for financial aid.
- Summer class schedules may change, so please be sure you check your school (hawaii.edu) email for any changes or updates.
- Application Deadline: **June 1, 2021**

Summer Application Process:

1. Complete and submit a **2020-2021 FAFSA** listing WCC in the school section (if you have not done so yet). If you need assistance in filing a FAFSA, please contact the Financial Aid Office at (808) 235-7449 or email at wccfao@hawaii.edu.
2. Please complete the attached **2021 WCC Summer Financial Aid Eligibility Form** and submit it to the Financial Aid Office by **June 1, 2021**.
3. The Financial Aid Office will notify you of your eligibility by email to your MyUH Services or hawaii.edu email.
4. You must notify the Financial Aid Office of any changes to your summer class schedule. Changes to your class schedule may impact your aid eligibility which could result in the repayment of financial aid.
5. Financial aid funds are disbursed on the first day of instruction for the session of your award(s).
